2023/74 **Minutes of the Parish Council meeting** The minutes of the meeting of Monday 23rd October 2023 were approved and signed by the Chairman as a true record.

2023/75 District Councillor Rachel Eburne's report

Following Storm Babet and Ciaran, SCC is working hard to help residents and businesses in affected homes and businesses; the Cosy homes initiative has been launched with a £2 million fund, eligible households can apply for free energy efficiency measures in their own homes, including rented properties. To understand what is happening locally, MSDC Officers were due to have a 'walk about' in Wetherden but owing to bad weather this has been deferred until next year.

2023/76 **County Councillor Andrew Stringer's report**

SCC are continuing giving support to Suffolk Farmers; as the Floods Authority, the Council are working on behalf of the Drainage Board to assist with flooding issues and are currently working though all reports; new footpath signs are gradually being replaced; refresher signs at Rectory Hill have been ordered but not yet installed, Cllr Stringer to chase; potholes reappearing, to continue reporting.

Public Participation

Matters brought to the attention of the parish council included: the covering over the 'No dogs' sign at the playing field, with white tape, Cllr Perry to action; proposed footpath from Wetherden to Elmswell, on MSDC's list but not about to happen as funding needs to come forward; a thank you to SCC for installing some new footpath signs; overgrown hedge on footpath 32 between Kate's Lane and Captain's Lane, ownership of the land/hedge to be identified, in the short-term to be reported on the Highways Reporting Tool; flooding at the bottom of Rectory Hill due to blocked drains will be covered when MSDC Officers are taken around the area; Haughley Youth FC have taken down the old goals and at their own expense have replaced them with new mobile goals. Cllr Perry to speak with Stowmarket United concerning the clearing up of the clubhouse and pitch after their matches.

A lot of weeding, clearing, and replanting in some areas has been carried out at the Townlands Garden; National Highways have surveyed the car park to see if they can provide assistance to resurface the car park. Cllr Perry to follow up.
